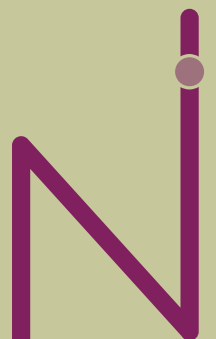

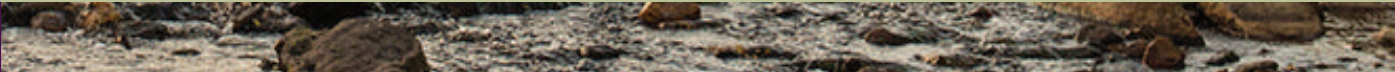
## **IMPLEMENT**
